IN a significant boost to Vedanta Facor's expansion plans, villagers of the neighbourhood areas coming out in large numbers in the Public Hearing held today expressed their support, even as they urged the district adminis tration to prevail over the ferrochrome major to be graceful enough in spend-ing through CSR activities for the growth and development of their villages.

Sources said the public hearing which

approved FACOR's proposed expansions.
